This is to inform that **Delhi State Legal Services Authority (DSLSA)** under the aegis of National Legal Services Authority (NALSA) will organize National Lok Adalats, in all Delhi District Courts Complexes. *i.e. Tis Hazari, Karkardooma, Patiala House, Rohini, Saket, Dwarka and Rouse Avenue Courts Complexes* for **amicable settlement** of all types of **civil** and **criminal compoundable cases** except divorce cases, during the year, 2024 as follows:-

1 <sup>st</sup> National Lok Adalat	09/03/2024
2 <sup>nd</sup> National Lok Adalat	11/05/2024
3 <sup>rd</sup> National Lok Adalat	14/09/2024
4 <sup>th</sup> National Lok Adalat	14/12/2024

Apart from the above District Court Complexes, the National Lok Adalat shall also be organized on the aforesaid dates at High Court of Delhi, Debt Recovery Tribunals (DRTs), Permanent Lok Adalats, Delhi State Consumer Disputes Redressal Commission and District Consumer Disputes Redressal Commissions.

Litigants/parties may move an application for listing their cases in the National Lok Adalat before concerned Court(s)/Forums/Tribunals where the case is pending at the earliest. In case of prelitigative matters, litigants/parties may move an application before the office of undersigned latest by seven days prior to the date of National Lok Adalat.
